# **Governor: Stay Home!**

### Governor Whitmer Signs "Stay Home, Stay Safe" Executive Order

On Monday, Governor Gretchen Whitmer signed the "Stay Home, Stay Safe" Executive Order (EO 2020-21), directing all Michigan businesses and operations to temporarily suspend in-person operations that are not necessary to sustain or protect life. The order also directs Michiganders to stay in their homes unless they're a part of that critical infrastructure workforce, engaged in an outdoor activity, or performing tasks necessary to the health and safety of themselves or their family, like going to the hospital or grocery store.

Effective at 12:01 a.m. on March 24, 2020, for at least the next three weeks, individuals may only leave their home or place of residence under very limited circumstances, and they must adhere to social distancing measures recommended by the Centers for Disease Control and Prevention when they do so, including remaining at least six feet from people from outside the individual's household to the extent feasible under the circumstances.

"In just 13 days, we've gone from 0 to over 1,000 COVID-19 cases," said Governor Whitmer. "This is an unprecedented crisis that requires all of us working together to protect our families and our communities. The most effective way we can slow down the virus is to stay home. I know this will be hard, but it will be temporary. If we all come together, get serious, and do our part by staying home, we can stay safe and save lives."

Additionally, under Executive Order 2020-21, all public and private gatherings of any number of people occurring among persons outside a single household are temporarily prohibited. People may leave the house to perform for limited, necessary purposes, and may engage in outdoor activities like walking, hiking, running, cycling, or any other recreational activity, consistent with remaining at least six feet from people from outside a person's household and with other restrictions imposed by prior executive orders.

The Bay County Heralth Department advises that YOU

- Go to the grocery store or pick up take-out food.
- Go to the pharmacy to pick up a needed prescription. • Engage in outdoor activities like walking, hiking, run-
- Go to the hospital or secure any care necessary to address a medical emergency or to preserve your health or the health of a loved one.
- Fill your car with gas.
- Return to Michigan to a home or place of residence from outside the State.
- Leave the State for a home or residence elsewhere.
- Walk your pets and take them to the veterinarian for needed medical care. YOU MAY NOT:

## **Town & Country Supermarket Seeing Shelves Refilled**

Town and Country Supermarket owner John Aspinall and his team have been working around the clock for over a week, trying to keep up with waves of customers in his store and an overloaded ordering system. Tuesday morning he received his first supply truck in over a week that included a mostly complete order. "The warehouse got slammed," he explained, "A truck that normally carries orders for three stores would have been full with the order from a single store. That means you'd need three trucks and three drivers to get everyone supplied. They just don't have that much excess capacity." As a result, the warehouse was only delivering about 40% of the stock that was ordered. In the case of something like toilet paper that saw panic buying and hoarding, the store's normal stock that would support them between the twice-weekly trucks was cleaned out in hours, and the next two partial deliveries were also bought out the same day they arrived. By Tuesday, the fill level was

closer to 90% on dry goods and 70% on most perishables. Frozen food stocks are still running behind, due to longer shipping and handling times because of the requirement to maintain freezer temperatures during shipment.

Supply-and-demand still rules though. The cost of some meat items has increased nearly 50% due to high demand. Some dairys have cut the production of 1% and 2% milk to focus on Vitamin D milk, which is their largest seller. Items such as eggs are in short supply, and instead of receiving the "store brand", low cost items, they may receive higher cost, name brand items with a resulting higher retail price. "We have not raised the price on ANY item unless our cost has increased," said Aspinall, "We WOULD NOT do that to our customers."

In addition to the supply-chain issues, the volume of

sales in the store has also seen a large increase. "If it wasn't

for the tremendous work of our associates, we'd have never

gotten through this," said Aspinall, "they've stayed late or come in at odd times to make sure the trucks got unloaded and product on the shelves. They're the ones that have made it possible to keep up with this level of demand. Heck, we've even set cases of product out on the floor, gone to get more, and come back to find that

### **Bay Metro Transit Suspends Fixed Route Service**

On Monday, March 23rd, Bay Metro Transit suspended fixed route service, Routes 1-11.

Bay Metro Transit will continue to operate DART demand-response service and will open the service up to the general public. However, all trips on DART will be limited to trips for ESSENTIAL SERVICES ONLY. These trips include medical trips for treatments, such as dialysis; trips to pick up prescriptions; grocery runs; limited rides to work – Bay Metro will not be transporting to Midland or SVSU for transfer. We ask the public not to call and put us in a position to make the decision for you as to what is or what is not an essential service. If you have to ask, it is not.

There will be no charge for this service. DART hours are 6:00 am until 7:00 pm Monday through

A US Department of Agriculture Grant has been secured to fund a wastewater Rate Study for the City. The study will analyze the City's Wastewater Fund, and make recommendations about full cost recovery (i.e. operating costs, debt and other expenditure requirements); a cost-based rate structure; consistency with industry standards; equity among customer classes; administrative efficiency (i.e. easy to understand and implement); and a capital funding plan. The cost of the study, approximately \$15,000, will be fully covered by the grant.

City Manager Bob Moffit also told the Journal that Pinconning Police Captain Terry Spencer has been cleared to resume work later this month. He will be working a parttime schedule due to budget considerations.

## **PASD Updates**

The Pinconning Area School District is in the same position as every other district and most businesses in Michigan: waiting for more information. In yesterday's Stay Home order, Governor Whitmer said she would issue "talking points" for schools, but nothing has been released as of press time. Individual districts throughout the state are unable to make any plans, and the state has to develop a plan that will be effective for every district from the smallest in the state (Chassel, in the Keweenaw Peninsula, closer to Fargo, ND, than Lansing) to the largest (Detroit). PASD Superintendent Mike Vieau told the Journal that the district is operating at a minimum staffing level, and waiting for more information.

At this the only program they have in operation is the distribution of food for students. They began last Wednesday and passed out over 1,500 meals of food for district students, three meals per day for three days. They have changed to providing seven days of food, three days on the Monday distribution and four days on the Wednesday distribution, and the number of students served has increased on each distribution. "This wouldn't be possible without the support of our staff and community volunteers," said Vieau.





To help protect the health and safety of our patients, families, health care staff and providers from the spread of COVID-19, Ascension Michigan is enforcing patient visitor restrictions for all of its hospitals and ambulatory sites. These restrictions are consistent with Gov. Gretchen Whitmer's Executive Order, EO 2020-7.

No visitors are permitted at Ascension Michigan hospitals except for:

- One visitor permitted for support of activities of daily living like bathing or eating for pediatric (under 21) and special needs
- One visitor for a surgery patient
- · One visitor for a hospice patient



### Tips to Comply With 'Stay Home, Stay Safe' Executive Order

When Michigan Gov. Gretchen Whitmer issued the state's "Stay Home, Stay Safe" Executive Order (EO 2020-21), she advised reporters during the press conference that the EO is just that – an order -- not a guidance

Put bluntly, those found to be in violation of the EO will be charged with a misdemeanor.

While the EO recognizes Michigan's food and agriculture industries and related workers as "Essential Critical Infrastructure" to ensure continued food security, Michigan Farm Bureau (MFB) and the Michigan Ag Business Association (MABA) are recommending farmers take some additional steps to ensure farm employees can avoid problems with local law enforcement.

Communicating to your employees will be important. It may not be immediately apparent to people across the state, including agribusiness employees reading news reports, that food and agricultural businesses can continue to operate as essential infrastructure. MFB recommends considering a communication to employees detailing your operational plans.

Michigan Farm Bureau is also encouraging farm employers to provide a letter to employees who are carrying out essential functions. The organization recommends employees be provided a brief in-transit letter on company letterhead identifying them as an employee of a food/ agricultural business, and referencing both the executive order and the DHS/CISA memo.

Health and safety remain paramount. This order is about protecting public health, and MFB strongly urges employers to review the social distancing and best practices information available both in the order and at Michigan.gov/coronavirus. In addition, the organization recommends taking a moment to review regular workplace safety procedures with your employees.

In accordance with Whitmer's EO 2020-21, and to protect the public health, the following components of the Michigan food and agriculture sector are deemed essen-

- Workers supporting groceries, pharmacies, and other retail that sells food and beverage products.
  - Workers supporting and operating gasoline stations.
- Restaurant carry-out and quick-serve food operations; carry-out and delivery food employees.
- Food manufacturer employees and their supplier employees including those employed in food processing facilities (packers, meat processing, cheese plants, milk plants, produce, etc.); livestock, poultry, seafood slaughter facilities; pet and animal feed processing facilities; human food facilities producing by-products for animal food; beverage production facilities; and the production of food packaging.
- · Farm workers including those employed in animal food, feed, and ingredient production, packaging, and distribution; manufacturing, packaging, and distribution of veterinary drugs; truck delivery and transport; farm and fishery labor needed to produce our food supply domestically.
- Workers who care for animals at veterinary clinics, animal shelters and research facilities. Veterinary clinics should only be performing essential life-saving procedures; all other non-essential procedures should be de-
- Farm workers and support service workers including those who plant, grow, and harvest agricultural commodities; commodity inspections; fuel ethanol facilities; storage facilities; and other agricultural inputs.
- Employees and firms supporting food, feed, and beverage distribution, including warehouse workers, vendor-managed inventory controllers, and blockchain man-
- Workers supporting the sanitation of all food manufacturing processes and operations from wholesale to retail.
- Company cafeterias, specifically in-plant cafeterias, used to feed employees.
- Workers in food testing labs in private industries and in institutions of higher education.
- · Workers essential for assistance programs and government payments.
- Employees of companies engaged in the production of chemicals, medicines, vaccines, and other substances used by the food and agriculture industry, including pesticides, herbicides, fertilizers, minerals, enrichments, and other agricultural production aids.
- Animal agriculture workers including those employed in veterinary health; manufacturing and distribution of animal medical materials, animal vaccines, animal drugs, feed ingredients, feed, bedding, etc.; transportation of live animals, animal medical materials; deceased animals for disposal; raising of animals for food; animal production operations; slaughter and packing plants; and associated regulatory and government workforce.
- Workers who support the manufacture and distribution of forest products, including but not limited to timber, paper, and other wood products.
- Employees engaged in the manufacture and maintenance of equipment and other infrastructure necessary to agricultural production and distribution.

MDARD has established an email address for industry, stakeholders, and consumers to submit questions and/or get clarification on specific areas of concern. MDARD-COVID19@michigan.gov NOTE: These businesses should to the extent possible follow guidance from the CDC, as well as state and local government officials, regarding strategies to limit disease spread, which includes social distancing, frequent handwashing and sanitizing of surfaces. Workers should be encouraged to work remotely when possible and focus on core business activities. In person, non-mandatory activities should be delayed until the resumption of normal operations. When continuous remote work is not possible, businesses should enlist strategies to reduce the likelihood of spreading the virus. This includes, but is not necessarily limited to, enhanced cleaning protocols, separating staff by off-setting shift hours or days, and social distancing. These steps can preserve the workforce and allow operations to continue.

Michigan Farm Bureau Legal Counsel Allison Eicher suggests farm employers should already be making plans to protect the safety of their workforce and maintain normal business operations to the extent possible, should COVID-19 have a significant impact now and in to the future.

- Leave the home to work unless your employer desinates you as a critical infrastructure worker.
- Participate in any public gatherings.
- Visit someone in the hospital, nursing home, or other residential care facilities (with limited exceptions).

Businesses that remain open for in-person work must take aggressive steps to minimize the virus's spread. They

- Promote remote work to the fullest extent possible.
- Restrict the number of workers present in-person on
- Keep employees at least six feet from one another to the maximum extent possible and enabling social distancing for customers who are standing in line.
- Any other social distancing practices and mitigation measures recommended by the Centers for Disease

### Consumer Response to COVID-19 **Drives Grocery Demand**

Escalated consumer purchases of many basic grocery items — in response to COVID-19 emergency orders temporarily closing Michigan restaurants for dining in - has taxed the logistical food supply chain throughout

Gov. Gretchen Whitmer's Executive Order issued earlier this week required all places of public accommodation, including restaurants, closed to the public for on-premises consumption until March 30 to mitigate the spread of COVID-19, protect the public health, and provide essential protections to vulnerable Michiganders.

It's also forced the food processing industry to expand hours of operation and redirect product processing and packaging that would have normally been destined to food service establishments as bulk goods to consumer-friendly packaged products, according to Michigan Farm Bureau President Carl Bednarski. That's no small

According to Michigan Restaurant and Lodging Association Vice President of Government Affairs John McNamara, restaurants normally provide 51% of the meals consumed on a daily basis. Based on 2018 figures, Michigan is home to 16,543 eating and drinking establishments, with \$17.9 billion in estimated sales, according to the National Restaurant Association.

"It's important Michigan take the necessary steps to protect public health, but we also realize the importance of supporting local retail, eateries and stores," said Gary McDowell, director of Michigan Department of Agriculture and Rural Development (MDARD).

"You can still get your favorite foods, just in a different way than before, as we work together to reduce the spread," McDowell continued. "I urge you to con-

tinue to support your area businesses, who are often the foundation of our local communities, by buying gift certificates for later use, getting take-out or delivery.'

MDARD advises that this is a time to prepare, not panic. Flooding the grocery and convenience stores doesn't allow them time to properly restock items consumers are looking to buy. While the supply chain is intact, and the food and items are available, giving grocery stores time to replenish inventory is critical to ensure everyone has access to what they need at the store.

Michigan Retailers Association's Meegan Holland said the organization is monitoring and interpreting the latest state and federal aid packages for their 5,000 member businesses — some of which are struggling during the

#### EGGS & RICE

- 2 c canned tomatoes 1/2 small onion, sliced
- 1/2 of a bay leaf
- 3 cloves
- 1 t sugar 1/2 t salt
- 2 T butter
- 2 T flour 3 c cooked rice
- 6 eggs
- 3 T grated cheddar cheese
- 1/2 c bread crumbs

DIRECTIONS: Simmer tomatoes, onion, bay leaf, cloves, sugar and salt in a saucepan for 10 minutes. Strain. Melt butter in a separate saucepan. Blend in flour. Add tomato mixture and cook until thickened, stirring constantly. Spread rice in a greased, shallow 2 1/2 quart casserole, making six hollows in it with a tablespoon. Break an egg into each hollow. Carefully pour tomato sauce over all. Sprinkle with cheese and bread crumbs. Bake at 350 degrees for 20 minutes or until heated through and eggs are firm.

### CHEESE & MUSHROOM STRATA

- 4 oz fresh mushrooms, sliced
- 1/2 c chopped onion
- 1/2 t marjoram 3 T butter, divided

DIRECTIONS: Melt 1 tablespoon butter in a medium skillet. Sauté mushrooms and onion with marjoram until tender. Spread remaining butter over one side of each slice of bread. Cut bread into 1/2 inch cubes. Arrange 1/2 of the bread cubes over the bottom of a lightly greased casserole dish. Pour mushroom mixture evenly over top. Cover with remaining bread cubes. In a bowl, blend together Colby cheese, Swiss cheese, Parmesan cheese, mustard, eggs, milk, salt and pepper. Pour over bread cubes. Cover with aluminum foil and refrigerate for several hours or overnight. Leave covered and bake at 350 degrees for 35 minutes. Uncover and bake for 15 minutes more. Let cool for 5 to 10 minutes before serving.

#### EGGPLANT-MUSHROOM CASSEROLE

2-1 lb egg plants, cut into 1 1/2 inch cubes

1 large onion, sliced thin

1/2 c butter

1/2 lb fresh mushrooms, small ones halved, larger ones quartered

2 cloves garlic, minced

2-14 oz cans Italian tomatoes

1/8 t aniseed

1 t salt 1/4 t pepper

2 T dry sherry

2 T ruby port

1/3 c grated Romano cheese

DIRECTIONS: In a large skillet, cover eggplant and onion with water. Simmer for 15 minutes, stirring several times. Drain well, squeezing out excess liquid. While eggplant is cooking, sauté mushroom and garlic in butter until golden. Add tomatoes, aniseed, salt, pepper, sherry and port. Add cooked eggplant and onion. Mix well. Spoon into a 2 1/2 quart casserole dish. Top with Romano cheese. Bake at 350 degrees for 30 minutes.

Q: I saw my Family Doctor last week for a blood pressure check & asked about the best way to treat symptoms of suspected COVID-19 virus infection; she told me that I shouldn't take Motrin (ibuprofen) for the fever & body aches that usually come with it, but she didn't have time to tell me why. Can you help?

A: I would congratulate your doctor for being so attentive to the medical literature on this topic. This recommendation came from an article in the highly respected British Medical Journal, published on March 17, 2020. The reason for the recommendation you received is that the entire class of nonsteroidal anti-inflammatory drugs (NSAID; ibuprofen & naproxen can be purchased without a prescription, but prescription NSAID's include [generic names] celecoxib, meloxicam, ketorolac,

etodolac, and several others) appears to block chemical reactions in the



body that lead to inflammation, which lessens the body aches that are largely caused by inflammation. The problem is that some of those same chemical reactions are crucial to mounting a defense against the COVID-19 virus, causing a person with COVID-19, who is taking NSAID's, to have much more severe symptoms than they might otherwise have. Also, if you are trying to isolate your elderly relatives from any possible infection and you are taking groceries to their home, it is best to have them leave the package on the front step or in the garage for at least 2 hours, because at this time of year, the combination of passage of time & relatively low temperature will greatly decrease the survival of organisms that you may have left there in preparing & delivering the package, lowering the chance of infecting the recipient of the package. 



price increase at the retail level for many basic household grocery staples, including eggs, dairy, and meats.

Longer-term Bednarski expects the price pendulum to swing in the opposite direction, at least at the farm-level.

"We're already hearing market forecasts calling for significant price declines in literally every major commodity sector of U.S. agriculture," Bednarski said. "Market analysts are predicting that a COVID-19-induced recession will cause producer pay-price declines of 20% in dairy and 30% to 40% declines in pork and beef products, for example."






